
RJ yields positive benefits, but...

- Little referrals to RJ services

Restorative justice programmes encourage offenders and victims and offenders to take part in a restorative justice program.

Restorative justice programmes are highly successful and offenders are less likely to re-offend after participating in a restorative justice program.

Restorative justice is cheaper than the national justice system, saving costs on legal expenses, prison, offender rehabilitation, victim support.

Your own story


